## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is milling and resurfacing U.S. 1 (State Road (S.R.) 5) from Post Road to Pineda Causeway S.R. 404 in the Town of Palm Shores, and rehabilitating the existing drainage outfall to the Indian River on U.S. 1 at Madrid Drive, reconstructing the portions of the outfall that are beyond rehabilitation.

The project will also make improvements to interconnect the traffic signals for approximately 1.8 miles south of the project between the signalized intersections of Lake Washington Road, Parkway Drive and Post Road. The interconnected signals allow the county to make coordinated updates in signal timing as needed to improve operation.

## WHAT TO EXPECT

Motorists should expect lane closures throughout construction. Electronic message boards and other signage will be used to alert motorists of traffic changes. Uneven pavement is a common, unavoidable roadway condition with projects that require resurfacing, as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction will become less apparent as the project progresses. Pedestrian detours will be placed in areas where the sidewalk is inaccessible during construction. Motorists and pedestrians are asked to exercise caution and reduce their speed while driving through the work zone.
