### State Road (S.R.) 426 Resurfacing, Seminole County

The Florida Department of Transportation (FDOT) will hold a public meeting regarding project plans on S.R. 426 from west of S.R. 417 to Eyrie Drive on Thursday, July 8, at 5:30 p.m. The purpose of this project is to enhance safety for pedestrians, bicyclists, and drivers and to improve the roadway surface by repaving this segment of S.R. 426. FDOT is offering multiple ways to participate in the meeting. All participants will receive the same information on the proposed project.
