## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is milling and resurfacing South Street (State Road (S.R.) 405) from south of Bobbi Lane to north of Swan Lake Drive to extend the life of the roadway. Pedestrian safety improvements include replacing the existing 6-foot-wide sidewalk with an 8-foot-wide sidewalk along the west side of South Street. A new 6-foot-wide sidewalk will also be constructed along the east side of South Street from Fox Lake Road to north of Joe Murell Drive.

Other improvements include upgrades to intersection lighting, improved crosswalks with a pedestrian waiting area, upgraded bus stops, and bicycle lanes. Additionally, the project aims to encourage safer driving speeds by adding raised medians and left turn lanes throughout the corridor.

## WHAT TO EXPECT

Motorists should expect lane closures throughout construction. Access to driveways and side streets will be maintained through out the project. Single lane closures should be expected on South Street between 8:00 p.m. and 7:30 a.m. during both weekdays and weekends.

Electronic message boards and other signage will be used to alert motorists of traffic changes. Uneven pavement is a common, unavoidable roadway condition with projects that require resurfacing, as the contractor must place different layers of asphalt during various phases of construction. Road conditions during construction will become less apparent as the project progresses. Pedestrian detours will be placed in areas where the sidewalk is inaccessible during construction. Motorists and pedestrians are asked to exercise caution and reduce their speed while driving through the work zone.

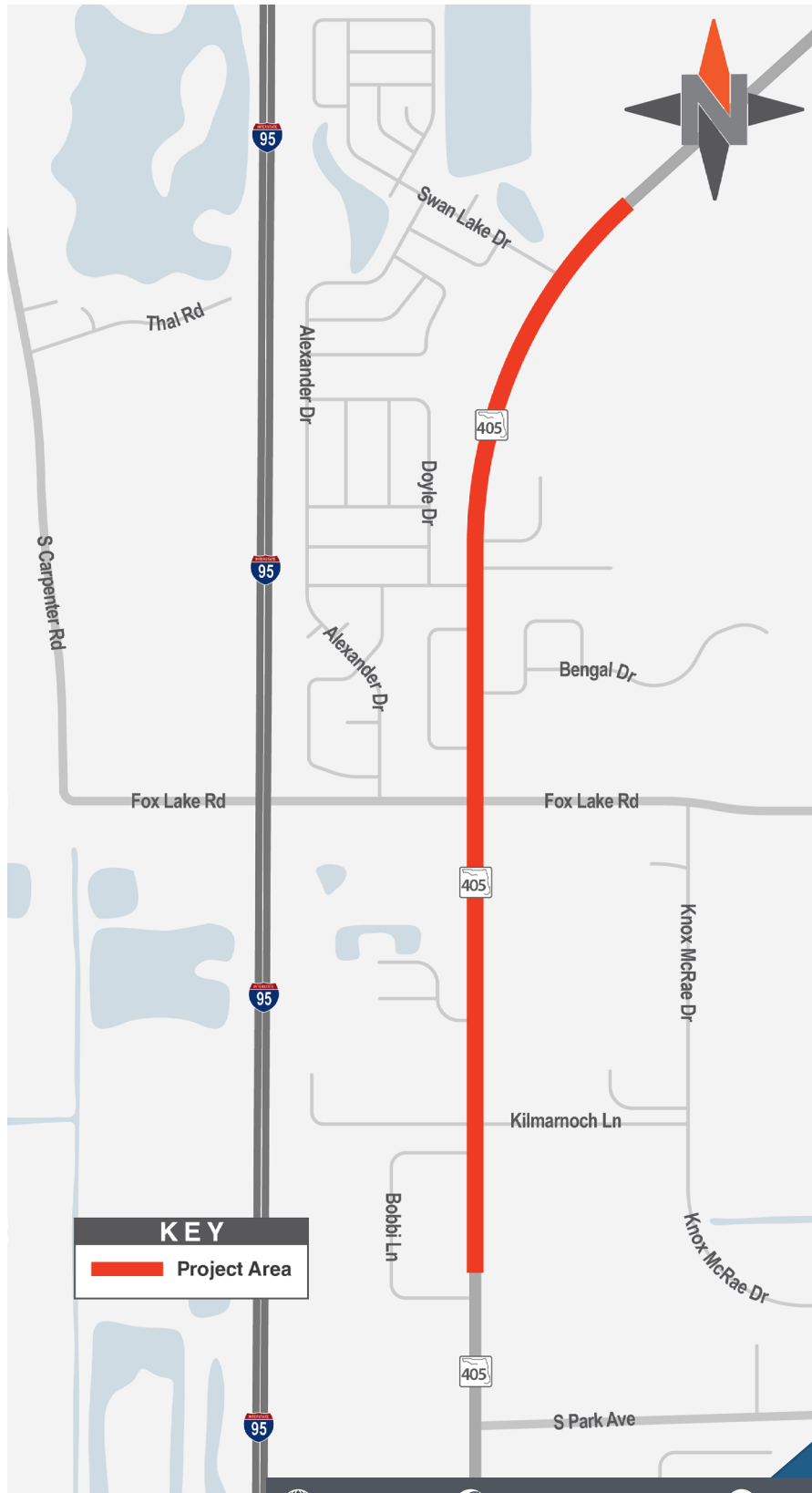
