S.R. A1A (North Ocean Shore Boulevard) from Osprey Drive to north of Mariners Drive

PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is resurfacing State Road (S.R.) A1A (North Ocean Shore Boulevard) from Osprey Drive to north of Mariners Drive in Flagler County to extend the service life of the existing roadway.

Additionally, various improvements will be made for pedestrian safety along this corridor. New midblock crossings will be installed at:

- Varn Park:
- South of W. Mayer Place at Treasure by the Sea;
- North of Painters Walk; and,
- South of Mariners Drive

Each midblock crossing will be equipped with a Rectangular Rapid Flashing Beacon (RRFB) to allow for pedestrians to more safely cross traffic when not at a traffic signal. RRFBs are pedestrian activated signals that flash yellow lights to motorists, indicating a pedestrian or bicyclist is ready to cross.

There will also be new raised medians installed north and south of Mariners Drive. These medians will not block access to any driveways or side streets, and their presence serves as a visual reminder for motorists to drive at safer speeds. Speed feedback signs will also be installed near the crosswalk at Mariners Drive. A new sidewalk will be installed from Mariners Drive to the midblock crossing at Varn Park, connecting to the existing sidewalk on the southbound side of S.R. A1A. Additionally, the restriping and narrowing of travel lanes will provide space for a designated bicycle lane and encourage slower motorist speeds.

WHAT TO EXPECT

Motorists can expect occasional single lane closures along S.R. A1A throughout the duration of the project. Work will be confined to the daytime hours of 7:00 a.m. to 7:00 p.m. It is important to be prepared for a slower posted speed limit of 35 mph on S.R. A1A throughout the project limits. Intermittent sidewalk detours will be utilized to accommodate pedestrian and bicycle traffic around the work area.

Electronic message boards and other signage will be used to direct traffic around closures. Motorists and pedestrians are asked to exercise caution while traveling through the work zone. Access to side streets, residences, and businesses will be maintained throughout the duration of the project.

The level of work activity will vary during different phases of construction, and the schedule may change due to weather or other unforeseen circumstances. 
