

# ROADWAY WIDENING

U.S. 17 (S.R. 15) from south of Spring Street to Lake Winona Road

## PROJECT DESCRIPTION

The Florida Department of Transportation (FDOT) is widening U.S. 17 (State Road (S.R.) 15) from two to four lanes from south of Spring Street to Lake Winona Road in Volusia County. A roundabout will also be constructed at the intersection of U.S. 17 and Spring Garden Avenue/Spring Garden Ranch Road. The purpose of these improvements is to increase capacity and enhance safety along U.S. 17.

Additional enhancements include the installation of a traffic signal at the U.S. 17 intersection with Ponce DeLeon Boulevard/Baxter Street, three new drainage ponds, and a new entrance into the Department of Forestry compound. Pedestrian improvements include a new 12-foot-wide shared-use path from Spring Garden Ranch Road to Lake Winona Road and a 5-foot-wide sidewalk from north of East Baxter Street to Spring Garden Ranch Road adjacent to the northbound lanes on U.S. 17.

## WHAT TO EXPECT

This project will be constructed in phases to maintain the safe and efficient flow of traffic on U.S. 17. At various times during construction, motorists can expect lane closures, changing traffic patterns, and short-term road closures with detours, as necessary. Temporary pavement will be used to shift traffic while new travel lanes and the roundabout are being constructed. One lane in each direction will be maintained outside of work hours throughout the project.

To enhance safety and help manage speeds within the corridor, temporary traffic signals will be installed at the U.S. 17 and Spring Garden Ranch Road intersection prior to construction of the roundabout. These signals will be removed once the roundabout is operational. Electronic message boards and other signage will be used to alert traffic of any upcoming closures.

Road conditions during construction are short-term and will become less apparent as the project nears completion. The contractor will maintain pedestrian access to sidewalks during construction using signed detours, channelizing devices, and/or temporary walkways and ramps, when appropriate. Access to businesses and residences will be maintained.

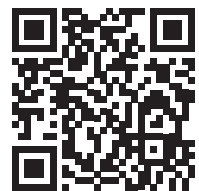
